THE ENLOES FAMILY data presented here was made available to the author by Mrs. Robert Hughes of Boulder, Colorado, and was the result of work done by Mrs. Hughes, Mary C. Wright, Mr. G. L. Brier, Evelyne McCracken and Mrs. John S. Slattery.

1. ENLOES, HENDRICK (1), was b. c.1632 in Holland, and d. bp 18 May 1708 in Balto. County, Maryland; res. Delaware, and Kent Co.; m. Christiana (---); pat. 100 a. Swallow Fork in Balto. Co. in 1683; d. leaving a will, 10 Dec. 1707 probate 8 May 1708, leaving 100 a. of Triangle, 100 a. Dutch Neck, and 30 a. Enloes' Meadow to s. Abraham, 1 shilling each to ch. John, Hester, and Margaret, and dower rights to w. Christiana; had iss.: HENRY, b. c.1075, d. 1703; JOHN, b. c.1668, d. c.1703, m. Elizabeth (---) who m. 2nd John Leakins; HESTER, m. after 1711 William Wright; MARGARET, m. (---) Durham; ABRAHAM, d. 1709 (122:116; data from Mrs. Hughes).

2. From "The Enlows of America 1670-1941" by E. E. Enlow dated July 1941

The first member of this family to be naturalized in America was probably Hendricks Enloes in the province of Maryland in 1674. Records show that in 1670 be attested the Will of Hugh Broadwater in Baltimore County, Maryland; and that in 1673 and 1687 there were surveyed for him at least five pieces of land from the lands of Lord Baltimore in Ann Arundel County, Maryland. His son John having died he willed his lands to his son Abraham Enloes.

3. From Thomas A. Enloe's manuscript:

My interpretation of the documentary material available indicates that Hendricks came to Maryland in and or around 1650 at the time Maryland was being settled by Lord Calvert. On 3 March 1661 Hendricks patented 200 acres of land in Maryland in what is now Baltimore County. In 1670 Hendricks made a deposition on a certain matter wherein he stated he "was about 38 years of age." this, or course, indicates a birth date of circa 1632. In 1674 Henry (Hendricks) Enloes and others applied for naturalization. This application was approved and is reproduced herein.

The first documentary material on Abram or Abraham Enloes of which I have knowledge is a naturalization application acted upon at New Castle, Delaware, on 21 February 1683, wherein he and others requested naturalization.

Although I believe so, I am in no position to state definitely that Abram and Hendricks were of any relation."

Province by and upon confidence of your Lordships declaration of the
second of July, 1649; whereby you did Impower your Governour from time
to time to grant Lands unto any person of French, Dutch, Spanish, Swedish,

or other foreign descent in the same and in as ample manner & upon the same terms & provisions as he thereby Impowered to grant Lands to any person or persons of British or Irish descent and during their said abode, they have been always faithful and obedient to your Lordships laws, yet for that your petitioners are not of British or Irish descent, they cannot take benefit of the laws and customs of this Province as other the said people of this Province of British or Irish descent may, to their great loss, hindrance, and prejudice as all to the deterring of diverse other of the same foreign nations aforesaid from coming into this Province and by consequence fore slowing the peopling of this Province with useful artificers and handy craftsmen.

May it therefore please your Lordship of your abundant goodness and wonted care of an over this providence that it may be enacted and ordained by the Right Honble the lord proprietary of this province by and with the advise and consent of the upper and lower houses of this present General Assembly, that your Lordships humblepetitioners:

that they and every one of them shall from henceforth be adjudged, reputed, and taken as natural borne people of this Province of Maryland, and also that they and every one of them shall and may henceforth by the same authority be able & adjudged to all intents and purposes able to demand, challenge, ask, have hold and enjoy and lands, tenements, rents, and Hereditaments within this Province as heir or heirs to any of their ancestors by reason of any descent, in fee simple, fee tayle, general or special, or remainder upon any estate tayle as aforesaid or by any other lawful conveyance or conveyances or means what so ever, as if they had been borne within this Province or were of British or Irish descent as aforesaid, and also that they and every one of them from hence forth shall be enabled to prosecute, maintain and avow, Justifie(justify) and defend all manner of actions, suites, complaints, or other demands whatsoever, as liberally, frankly, freely, lawfully and securely as if all of them had been natural borne within the Province of Maryland.

This document provides the primary basis for showing **Hendricks Enloes** place of birth as the Netherlands
